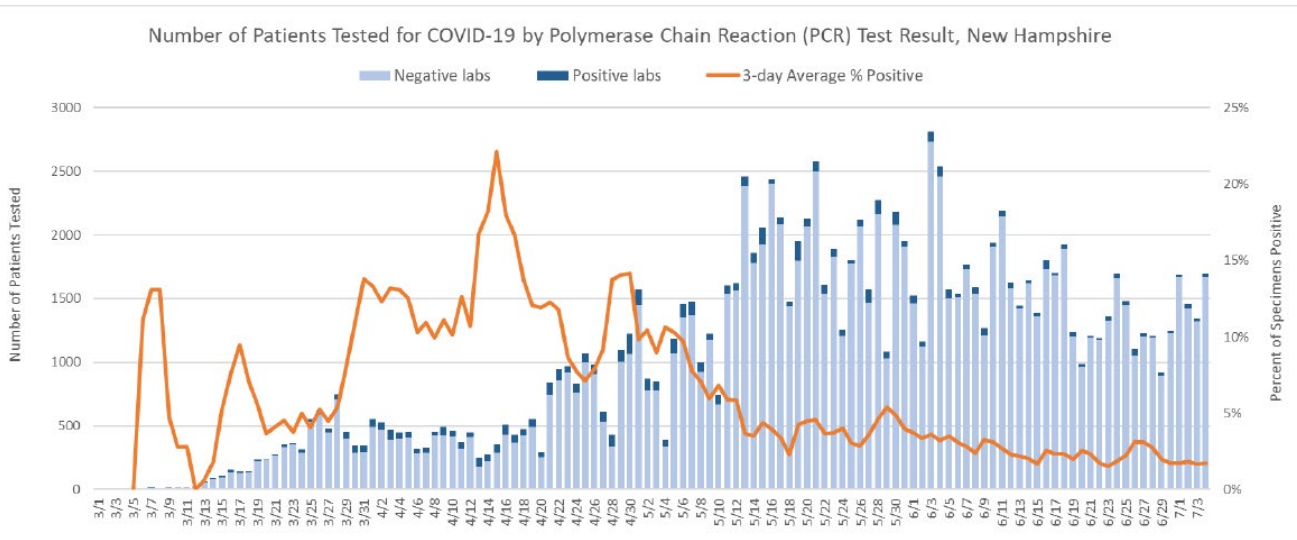

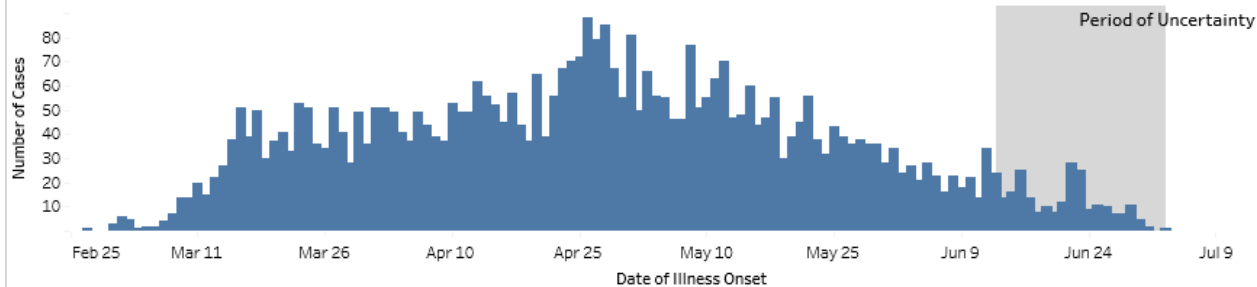

EPIDEMIC CURVE: ONSET OF ILLNESS AMONG PERSONS WITH CONFIRMED COVID-19

(n= 4531) ?

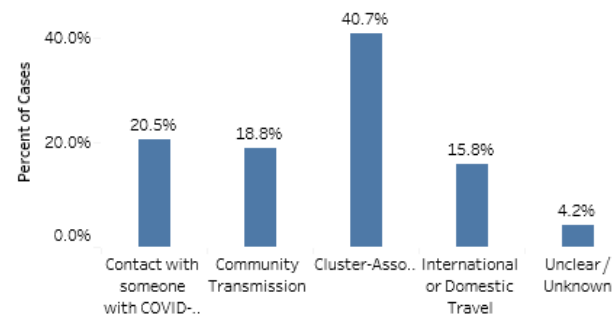
The epidemic curve is a visual presentation of the progression of COVID-19 in NH that shows the number of people with confirmed illness on the specific date each person first started to experience symptoms. Because there is a delay between when symptoms develop and a confirmed case is reported to DHHS, the data on a given date will change over time.



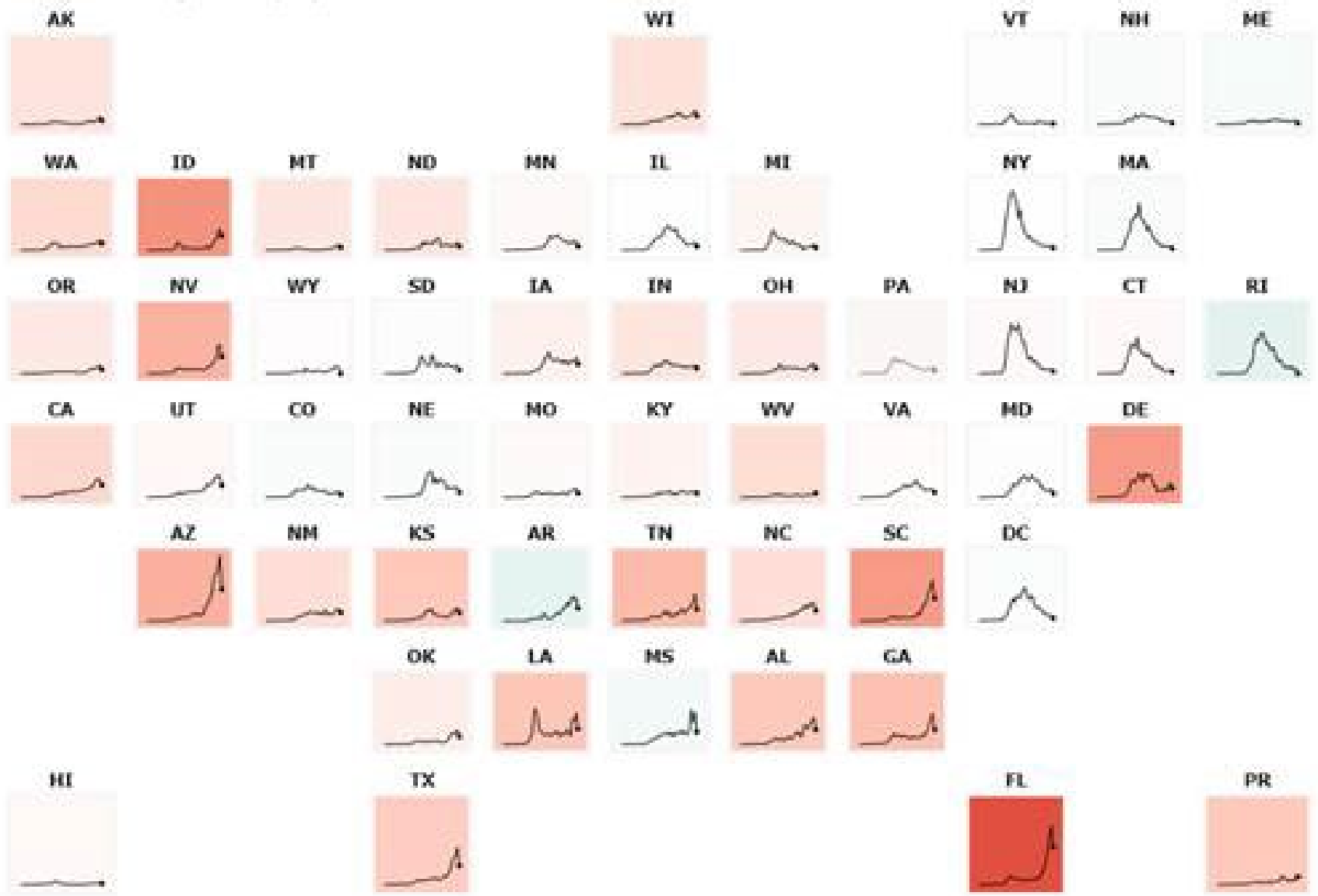
Onset Date Unclear / Unknown: 1,366 **Note:** Not all confirmed cases are included in this figure due to the person having an unclear onset date or no onset date because they did not experience any symptoms.

What We Know

- ▶ Coronavirus is believed to be spread mainly by respiratory droplets
 - ▶ The 6-feet-away rule of social distancing is meant to keep people out of the splash zone for respiratory droplets.
 - ▶ Wearing a face covering reduces the chance that *my* respiratory droplets reach *you*.
 - ▶ Increased use of face coverings = reduced chance for transmission
- ▶ Individuals with mild symptoms – and even people without symptoms – can spread the virus through their respiratory droplets
- ▶ The virus can incubate for up to 14 days before symptoms appear
 - ▶ It can be several more days before severe illness sets in.
 - ▶ Time lag between exposure and symptoms

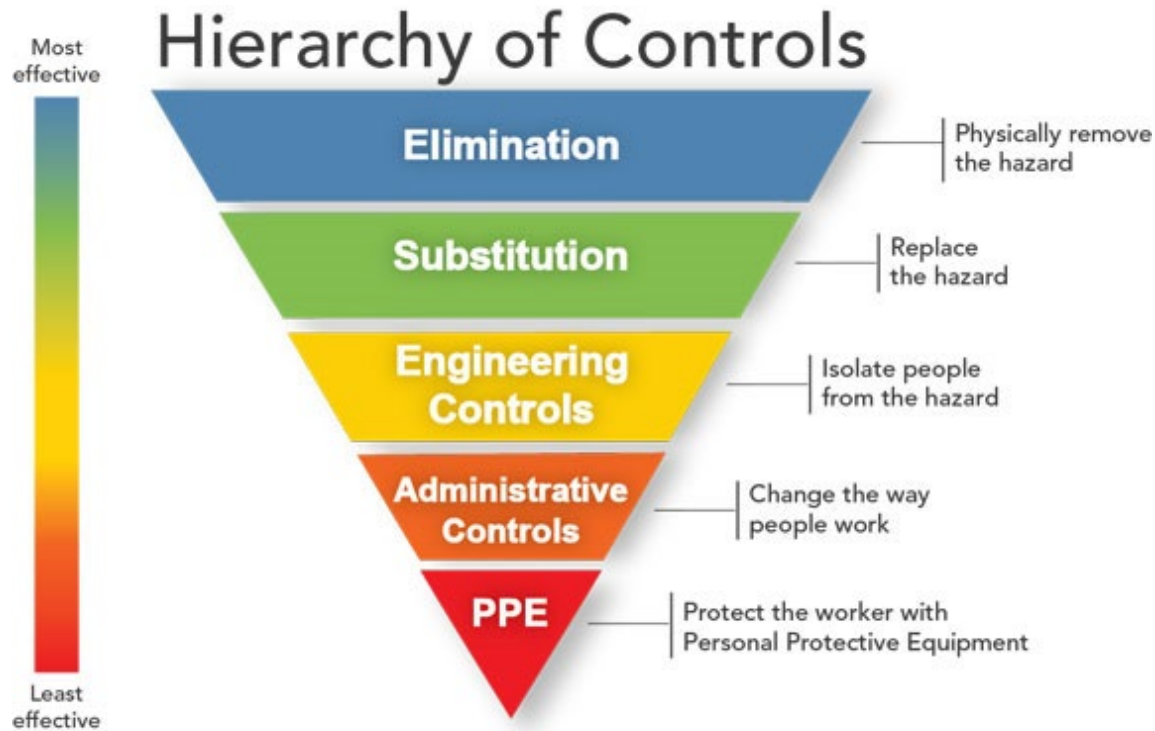
What is Mitigation?



- ▶ Emphasizes individual responsibility for implementing recommended personal-level actions
- ▶ Empowers businesses, schools, and other settings to implement appropriate actions
- ▶ Prioritizes settings that provide critical infrastructure services
- ▶ Minimizes disruptions to daily life to the extent possible and ensuring access to health care and other essential services.

HOME ALONE OR WITH HOUSEMATES

- Stay home as much as possible.
- Try to allow only people you live with into your home.
- Wash your hands.
- If you're sick, stay home and isolate from housemates.



OUTDOOR ACTIVITIES

- Wash your hands and don't touch your face.
- Stay at least 6 feet from people you don't live with.
- Wear a mask.
- Avoid shared surfaces, like swings or benches.



OUTDOOR GATHERINGS

- Wash your hands and don't touch your face.
- Stay at least 6 feet from people you don't live with.
- Wear a mask.
- Don't share food, toys, and other items, and avoid shared surfaces.



INDOOR GATHERINGS

- Wash your hands and don't touch your face.
- Stay at least 6 feet from people you don't live with.
- Wear a mask.
- Don't share food, toys, and other items, and avoid shared surfaces.

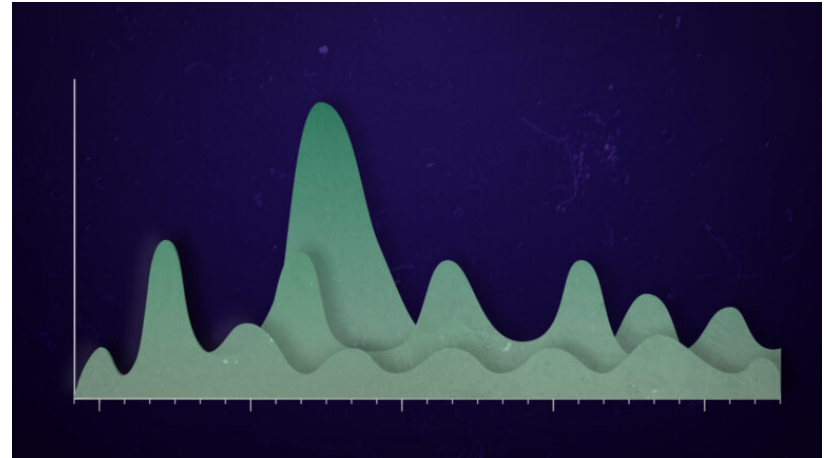

Stay-At-Home / Stay-At-Home 2.0 / Safer-At-Home

- ▶ Emergency Order #17 (Stay at Home), Emergency Order #40 (Stay-At-Home 2.0), Emergency Order #52 (Safer-At-Home)
 - ▶ This Order shall not apply to . . . local governments”
- ▶ Municipalities must determine what is appropriate for themselves regarding reopening.
- ▶ BUT, there is some state guidance.

Who Determines What Happens in a Municipality?



The governing body, i.e. the select board, has the authority to determine the rules for use of most municipal property. RSA 41:8; RSA 41:11-a.



The notable exception is libraries. Libraries have their rules set by the library trustees. RSA 202-A:6; RSA 202-A:11.



Town forests, conserved lands, and recreation areas are the other likely exceptions, however, town meeting may have delegated authority to another board or body. RSA 41:11-a; RSA 31:112, RSA 35-B, RSA 36-A:4.

Best Practices



- ▶ Get everyone on the same page.
 - ▶ Schedule meetings with EMD, Police Chief, Fire Chief, Health Officer, Town Administrator/Manager, Select Board, Library Trustees, etc. to hash out rules.
- ▶ Listen to DHHS, CDC, & Reopening Taskforce Guidance to determine what reopening rules may be required, and what reopening rules may be prudent to adopt.

Three Advice Themes



Continue to employ phone, online or limited appointment delivery of service:

- ▶ Continue to allow applicants for vital records, welfare and other municipal services to apply online, via email, phone or other accessible manner, and continue to provide notice of how to apply remotely at conspicuous places on the town website and at town hall.

Continue to employ remote meetings and hearings, where possible:

- ▶ Continue to utilize software to host remote meetings and hearings, or, at the very least, allow the public to listen or join in-person meetings remotely.

Continue to abide by social distancing guidelines:

- ▶ Craft rules which require social distancing for employees and the public while in town buildings and ensure that modifications have been made to accommodate social distancing.

▶ **Remote Meetings**

- ▶ Allowed Under Emergency Order #12
- ▶ Allowed “for the duration of the State of Emergency”

▶ **Remote Access**

- ▶ No prohibition on boards adopting rules of procedure which allow for continued remote access or participation in meetings past the end of the State of Emergency.
 - ▶ May see an increase in interest if utilize provisions of Emergency Order #56 allowing governing body to reduce appropriations.

▶ **Remote Payments**

- ▶ GOFERR funds may be used for the fee on credit card transactions.
- ▶ May see an increase if utilize provisions of Emergency Order #56 allowing payment plans for property taxes

Remote Services

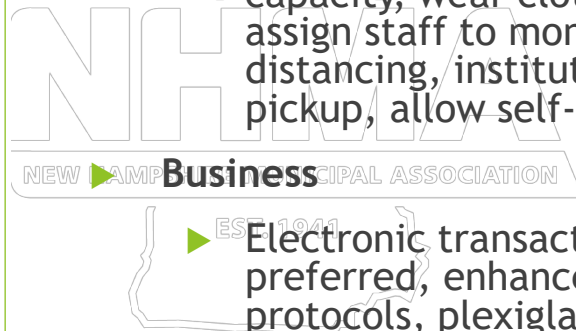
Town Hall & Other Municipal Buildings



- ▶ Look to what has already been created, e.g. for libraries, as guidance for the rules to adopt.
- ▶ Some best practices will be hard to get everyone to comply with, e.g. face masks.
 - ▶ If you do adopt a face mask rule, have some available for the public, but consider charging a reasonable fee - i.e. the cost of acquisition - for those masks to discourage people from collecting masks from the municipality.
 - ▶ Remember that items which are paid for once are not eligible for reimbursement, e.g. if a member of the public pays for a mask, that mask cannot be submitted for reimbursement to FEMA or GOFFER.
- ▶ Plan for what happens when someone violates the rules.

Libraries

- ▶ State Reopening Taskforce has created guidelines for libraries.
- ▶ **Employees**
 - ▶ Wear cloth masks, have hand sanitizer available, stagger shifts/work to allow social distancing, screen for illness.
- ▶ **Public**
 - ▶ Limit public to less than 50% capacity, wear cloth masks, assign staff to monitor social distancing, institute curbside pickup, allow self-checkout.
- ▶ **Business**
 - ▶ Electronic transactions preferred, enhanced cleaning protocols, plexiglass barriers, suspend food/drink offerings, continue to allow remote work, quarantine books for 72 hours, offer remote services as much as possible.





Libraries: Part 2

- ▶ N.H. Library Association has also created guidance.
- ▶ Very detailed - 38 pages long.
 - ▶ Envisions 6-stage reopening, focusing on digital delivery of services, and movement toward allowing more people into the library, with an eventual result of a full reopening with enhanced digital services.
 - ▶ Walks through the process of reopening - from basic questions to ask regarding roles and responsibilities of governing body and employees to how to accommodate shifts in workload, work schedule, and interaction with public.

ADAPT

Planning for the Future

- ▶ The future is uncertain, but we do know a few things:
 - ▶ The Governor cannot prevent out-of-staters from entering New Hampshire.
 - ▶ Record setting outbreaks are happening in most other states.
- ▶ Set up your reopening team.
- ▶ Make your plan
 - ▶ Remember to ask what happens if you have an outbreak.
 - ▶ Note that it's a relatively good time to acquire supplies.
- ▶ Schedule routine "reviews" new guidance and then-current circumstances.
 - ▶ Keep in mind that changing circumstances may necessitate more frequent meetings.
 - ▶ Change your rules to suit then-current guidance and circumstances.

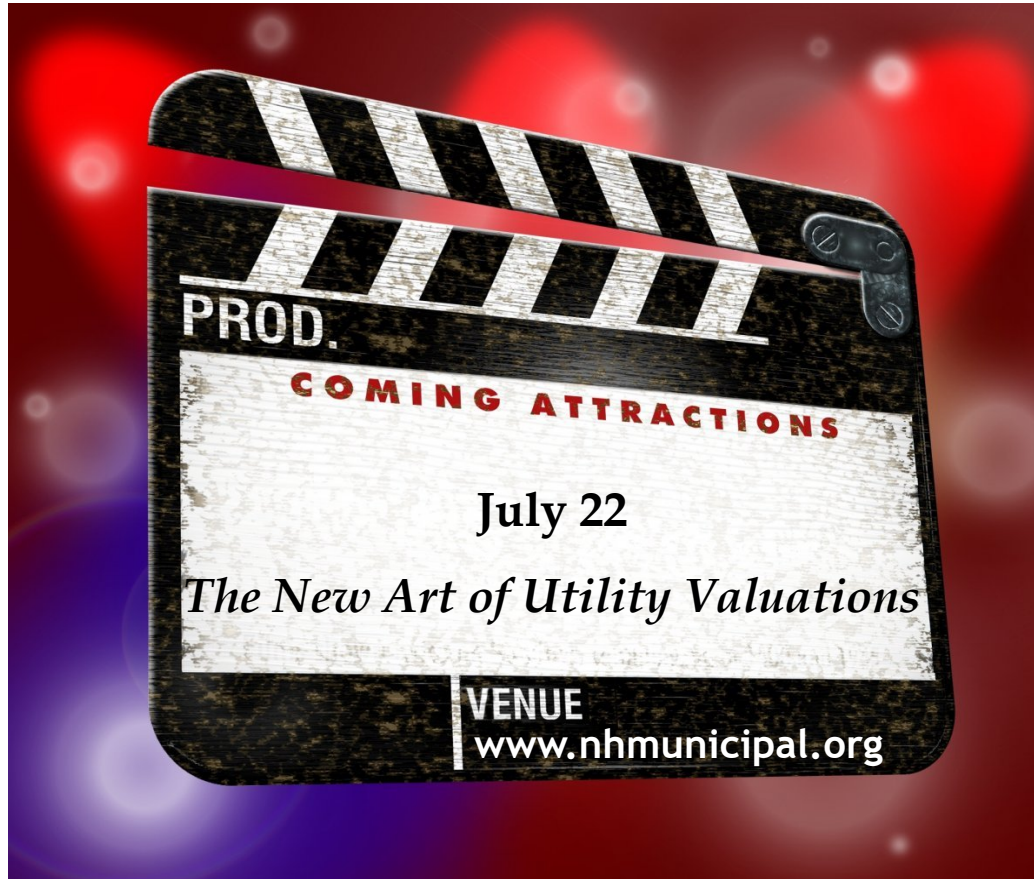
